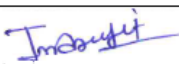
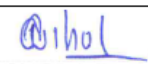
3. Core Principles

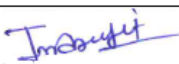
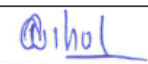
7. Review and Continuous Improvement
