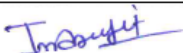
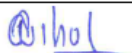
5.1 Local, Regional, and National Engagement

Monitoring and Reporting: We will continuously monitor the progress of our recycling strategy and report on key performance indicators through regular internal reviews and public disclosures.

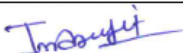
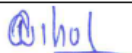
7. Review and Revision
