2. Scope

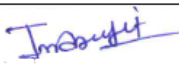
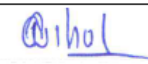

4. Emissions to Air

4.1 Quantification and Public Disclosure

Annual Disclosure: Raviraj Foils Ltd. will quantify and publicly disclose Material Emissions to Air from all activities on an annual basis, including those within our Area of Influence, where possible.

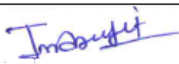
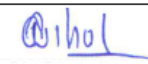

Impact Assessment: We will assess the potential impact of our emissions on human health and the environment, including air dispersion modeling that considers meteorological conditions, terrain, and sensitive receptors such as residential areas and schools.

Plan Improvement: Post-review, any identified improvements will be implemented to ensure the effectiveness of the plans in meeting objectives, stakeholder expectations, and legislative requirements.

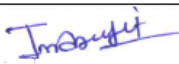
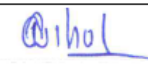
5. Public Disclosure and Verification
