Responsibility: Raviraj Foils Ltd. is committed to managing water resources responsibly and addressing water-related risks.

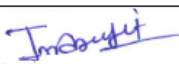
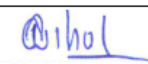
Consultation: Engage with affected populations and organizations, including Indigenous Peoples, in the development and implementation of water management plans.

Regular Review: Water management plans will be reviewed at least every five years to evaluate their effectiveness and progress towards targets.

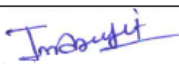
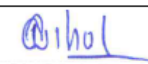
Changes and Control Gaps: Review the plans in response to significant changes in the business or if any control gaps are identified.

Affected Populations: Proactively communicate with affected populations and organizations regarding water management plans, especially if they are materially affected.

Guidance: Utilize guidance from frameworks such as the Alliance for Water Stewardship – International Water Stewardship Standard. Consider emerging work on context-based water targets aligned with local and global public policy objectives.

Communication Channels: Utilize appropriate communication channels to engage with affected populations and organizations.

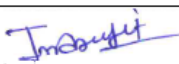
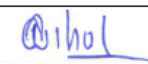
6. Review and Continuous Improvement

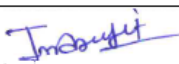
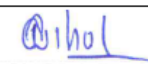
