Protection of Outstanding Universal Value: Ensure that operations in or near World Heritage Properties do not compromise their outstanding universal value and integrity.

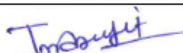
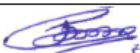
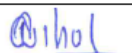
4. Policy Guidelines

World Heritage List and Tentative Lists:

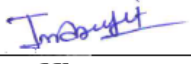
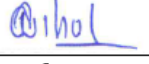
