Management Plans: Develop and implement management plans to protect the special values of Protected Areas.

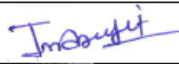
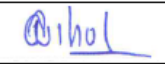
Transparency: Publicly disclose management plans in an accessible manner.

Integration: Integrate management plans with other relevant management systems and risk-based approaches.

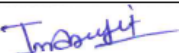
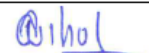
Implementation: Ensure that the Entity's activities and Facilities do not adversely impact the special values for which the Protected Areas are designated.
