1. Purpose

Raviraj Foils Ltd. is dedicated to respecting the legal and customary rights of Affected Populations and Organisations in their lands, livelihoods, and use of natural resources. This policy outlines our commitment to identifying, preventing, and mitigating significant impacts from our operations, ensuring these impacts are managed in a way that protects Human Rights and promotes sustainable development.

2. Policy Statements

2.1 Impact Management Plan

- a. Implement a plan to identify, prevent, monitor, mitigate, and account for any significant impacts from operations, including health and safety, social and cultural Human Rights, and environmental impacts.
- b. Develop the plan in consultation with, and where possible, with the participation of Affected Populations and Organisations to ensure it meets their needs and circumstances.

2.2 Local Community Development

c. Commit resources to support Local Community development, focusing on initiatives that benefit the livelihoods and well-being of Affected Populations and Organisations. Initiatives may include capacity building, micro-credit schemes, improved farming practices, and governance models for shared natural resources.

2.3 Regular Review and Updates

d. Review the impact management plan at least every five years, or more frequently if there are significant changes to the business that materially alter environmental, social, and governance risks.

2.4 Ongoing Engagement and Grievance Mechanism

- g. Engage in continuous dialogue with Affected Populations and Organisations, ensuring their concerns are addressed through clear and effective grievance mechanisms.
- h. Explore opportunities to support the livelihoods of Affected Populations and Organisations in ways that are equitable, culturally appropriate, and non-dependent.

2.5 Gender Sensitivity and Inclusion

i. Ensure that the impacts on women and other vulnerable groups are specifically considered and addressed in the impact management plan. Adapt engagement processes to include these groups in decision-making, ensuring their rights and interests are protected.

3. Application

3.1 Project Scope

- a. This policy applies to all new projects, expansions, and significant operational changes across all facilities of Raviraj Foils Ltd.
- b. The policy is applicable to all projects initiated after Raviraj Foils Ltd. joined the Aluminium Stewardship Initiative (ASI) and those initiated from January 1, 2022, onwards.

4. Points to Consider in Implementing Criterion 9.7

4.1 Legal and Customary Rights

c. Address the gender-specific impacts of operations, including those related to environmental changes that affect women's ability to provide for their families. Ensure that compensation and employment do not disproportionately favor men, creating imbalances in community dynamics.

d. Establish ongoing frameworks for regular discussion, consultation, and interaction with Affected Populations and Organisations, ensuring inclusivity, equity, cultural appropriateness, and rights-compatibility in all engagement activities.
